TEMPORARY INJUNCTION

Plaintiffs, Texas Medical Technology Corporation, iNitrile Inc., and Omri Shafran (collectively Plaintiffs) filed their Original Petition, Application for Temporary Restraining Order, Temporary Injunction, and Permanent Injunction ("Petition") against Defendants Aidor LLC. International, **IGIN** Hygiene PTE, **MYFOREXNEWS** Smart Ltd., FINANCEBROKERAGENEWS Ltd., wibestbroker.com, trademarketnews.com, jioforme.com, Orna Goldberg, Sophie Born, Alexander Zane, Marija Knapic, Marin Severdija, Shimon Avshalom, Yom Tov Sardheli, Noa Kroll Ketter, GeoMatrix Ltd., and Aviv Antebi (collectively, Defendants). This Court granted Plaintiffs Temporary Restraining Order on October 28, 2021 and Plaintiffs posted the required bond and issued notice of the Temporary Restraining Order to Defendants. The Court heard the Plaintiffs' Application for Temporary Injunction limited to Defendants MYFOREXNEWS Ltd., FINANCEBROKERAGENEWS Ltd., jioforme.com, Sophie Born, Marija Knapic, and Marin Severdija (the "Enjoined Defendants") only on December 2, 2021.

Based on the evidence, arguments of counsel, and facts presented the Court finds as

follows:

All of the Enjoined Defendants were provided notice of the temporary injunction hearing.

It clearly appears from the facts presented that unless the Temporary Injunction is granted, the Enjoined Defendants will violate applicable law and disrupt the prior status quo between these parties due to the publishing of defaming and disparaging words about the Plaintiffs and their business interests prior to a trial on the merits. Examples are included on the attached **Exhibit A**, which is incorporated into this Temporary Injunction.

The Plaintiffs will suffer irreparable injury in the absence of this Temporary Injunction due to harm to their reputations and ability to obtain financing or investments. The risk to the Plaintiffs is both immediate and irreparable, and there is no adequate remedy at law. Additionally, the Plaintiffs have demonstrated a likelihood of success on the merits of their claims, and a balancing of the equities strongly favors the granting of this Temporary Injunction.

The Court therefore **ORDERS** that the Enjoined Defendants and each of their officers, agents, servants, employees, and attorneys – and all other persons who are in active concert or participation with these persons or entities (including but not limited to web services platforms, domain name providers, web hosting providers, web security and performance services, and internet search engines) – are ordered to remove from their websites or prevent access to the articles listed on **Exhibit A** and all other disparaging and defamatory articles referring to Plaintiffs or persons or businesses related to Plaintiffs as committing fraud, engaging in a scam, or participating in patent infringement, specifically including but not limited to the examples on **Exhibit A**, until at least the trial on the merits of this case.

It is further **ORDERED** that this Temporary Injunction is binding upon Defendants MYFOREXNEWS Ltd., FINANCEBROKERAGENEWS Ltd., jioforme.com, Sophie Born,

Marija Knapic, and Marin Severdija and their officers, agents, servants, employees, and attorneys, and upon those persons in active concert or participation with the Enjoined Defendants (including but not limited to web services platforms, domain name providers, web hosting providers, web security and performance services, and internet search engines) who receive notice of this Order.

It is further ORDERED that the trial of this matter shall be set for October 3, 2022 ____, 202___.

This Order shall not be effective unless and until Plaintiffs have executed and filed with the clerk a bond, in conformity with the law, in the amount of \$100.00. The Court authorizes the continuation of the bond set for the Temporary Restraining Order.
